2. All cars up to 1450c.c (more than 2 valves per cylinder)
3. Cars from 1451c.c to 1650c.c (2 valves per cylinder)
4. Cars from 1451c.c to 1650c.c (more than 2 valves per cylinder)
5. Cars from 1651c.c to 2050c.c (2 valves per cylinder)
6. Cars from 1651c.c to 2050c.c (more than 2 valves per cylinder)
7. Specials & Buggies up to 650c.c
- 7a. Specials & Buggies from 651c.c

PENALTIES

Double Drivers and re-runs must wait a minimum of two timed runs before re-entering the track.
 Five seconds for striking or passing on wrong side of a marker.
 Any competitor found speeding in paddock 5 second penalty, second offence = exclusion.
