



## **Supplementary Regulations**

### **Autocross (LS) Sept 20th**

**Venue: Co. Cavan Motor Club Venue, Hutcross, Latton, (Off Ballybay / Cootehill Rd)**

**Authorised by Motorsport Ireland. Permit No. 20/199**

To be held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland Standard & Regulations for all Non-Championship Autocross Events, Appendix 86 & 87 of the current Motorsport Ireland Yearbook, these Supplementary Regulations, Current HSE / Government Regulations, & guidelines regarding Covid – 19, and any further regulations which may issue. The event is organized and promoted by Co. Cavan Motor Club Ltd.

#### **SCHEDULE:**

- Entries open on publication of these regulations
- Entries close: Tuesday 15 Sept at 5pm

**Entries will be limited to a maximum of 50**, if more than 50 entries are received, a reserve list will operate on a first come / first served basis. Due to Covid -19 restrictions all Motorsport Ireland events will be restricted to competitors / service crew members who are resident on the

island of Ireland, until further notice. All paid entries received by Monday 14 Sept will qualify for a draw for a free entry to the event, as per the Motorsport Ireland early entry incentive scheme.

Covid – 19 declaration forms and indemnities must be signed by the competitor, in order to facilitate this, please note that GCR 68 is being waived for the time being. These forms will be sent to the competitor upon receipt of their entry and **must be completed and returned electronically to the Event Secretary 3 days before the event.**

**This event is closed to spectators – No exceptions (strictly 1 competitor + 1 allowed in)**

**ORGANISATION:**

- Social distancing to be observed at all times.
- All competitors & officials must wear a mask at all times and while attending check in, scrutiny, drivers briefing – No exceptions.
- All competitors are asked to please bring your own pens, PPE, i.e. masks, sanitizer, gloves, & wipes.

- Temperature checks will be taken on arrival at the venue.
- All Drivers must be in possession of a valid competition licence & vehicle logbook.
- Competitors are asked to stay with their own vehicle at scrutiny.
- All competitors must have the labels on their safety gear / racing suits showing and ready for inspection at scrutiny to avoid any unnecessary handling.
- All competition cars / buggies must pass scrutiny as per Appendix 2 of MI Yearbook 2020.
- As per Appendix 86 9.8, Smoking is strictly prohibited in the Paddock or Service Area.
- Mud flaps are obligatory on all wheels.

### **CLASSES:**

- Class 1: All cars up to 1450cc (2 valves per cylinder)
- Class 2: All cars up to 1450cc ( more than 2 valves per cylinder)
- Class 3: Cars from 1451cc to 1650cc (2 valves per cylinder)
- Class 4: Cars from 1451cc to 1650cc (more than 2 valves per cylinder)
- Class 5: Cars from 1651cc to 2050cc (2 valves per cylinder)
- Class 6: Cars from 1651cc to 2050cc (more than 2 valves per cylinder)
- Class 7: Specials & Buggies up to 650cc
- Class 7A: Specials & Buggies 651cc
- Class 8: Juniors. Cars up to 1650cc only. Must be under 21 before 1<sup>st</sup> Jan 2020
- Class 8a: Juniors. Saloon Cars up to 1450cc for 14 – 16 year olds holding a Junior Speed Licence.

### **All CARS MUST BE ENTERED IN CORRECT CLASS**

### **DOUBLE DRIVING:**

- Double driving will be allowed.
- Cars being double driven must be sanitized by the driver getting out, and must also be sanitized by the driver taking over.
- Double drivers and re-runs must wait a minimum of 2 timed runs before re-entering the track.
- Sharing of helmets, balaclavas, gloves or other equipment is not allowed due to Covid-19, except for family members living in the same household.

**PENALTIES:**

- Any competitor found SPEEDING in the paddock – 5 Second Penalty, 2<sup>nd</sup> Offence – Exclusion.
- Five seconds for striking a barrel, or passing on the wrong side of a marker.
- Competition cars must not leave the venue at any time under their own power, either before, during or after the event – Penalty, **Exclusion**.

**AWARDS:**

**Fastest time of Any 3 Runs out of 5**, added together for results (if weather or daylight does not allow for 5 runs, best 3 out of 4 will be for results, this will be announced at Drivers briefing).

- Overall Award for Cars = Trophy, and 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> in each class
- Overall Award for Buggies & Specials = Trophy, and 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> in each class

### DECLARATION OF INDEMNITY

In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified the Co.Cavan Motor Club Ltd(Organising Club), Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents. Furthermore, in respect of any parts of this event on ground where Third Party Insurance is not required by law, this Agreement shall in addition to the parties named above extend to all and any other competitor(s) and their servants and agents and to all actions, claims, costs, expenses and demands in respect of loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s).
